
I, Harvard L. Lomax, being duly sworn, do hereby, under penalty of perjury, depose and say:

I, MICHAEL M. WISNER, hereby acknowledge receipt of the required forms and filing date schedule for the reporting of campaign contributions and campaign expenses pursuant to the Nevada Election Campaign Practices Act. I understand that:

- ◆ I must file the prescribed forms by the specified statutory date for each reporting period (timely postmark is acceptable if sent by certified mail).
- ◆ A violation of the reporting requirements set forth in Chapter 294A of the NRS may result in a civil penalty of not more than \$5,000 for each violation and payment of court costs and attorney's fees.
- ◆ Late reports are subject to civil penalties of up to \$100 for **each day** that **each report** is late.
- ◆ The reports are to be filed with the officer with whom I filed my declaration of candidacy or acceptance of candidacy.
- ◆ I **must** file the required Contributions & Expenses Reports even though:
 - (1) I neither receive campaign contributions nor make campaign expenditures;
 - (2) I withdraw my candidacy;
 - (3) I have no opposition;
 - (4) I lose the primary; or
 - (5) My name does not appear on either the primary or general election ballot.
