# IN KIND CONTRIBUTIONS AND EXPENSES REPORT

**NRS 294A.362 REQUIRES IN KIND CONTRIBUTIONS AND EXPENSES TO BE REPORTED SEPARATELY. REPORT ALL IN KIND CONTRIBUTION AND EXPENSES ON THE FOLLOWING PAGES.**

**IN KIND CONTRIBUTION IS DEFINED AS THE VALUE OF SERVICES PROVIDED IN KIND FOR WHICH MONEY WOULD HAVE OTHERWISE BEEN PAID.**

*In kind contributions and expenses include: paid polling and resulting data, paid direct mail, paid solicitation by telephone, any paid paraphernalia that was printed or otherwise produced to promote a campaign and the use of paid personnel to assist in a campaign. An in kind contribution may also include, but is not limited to: goods and services such as billboards, office space, printing, food and beverage and yard signs.*

**The donor of in kind contributions shall furnish to the recipient (candidate or other person), a written statement setting forth the actual cost of those services or the fair market value within 30 days after the time he furnishes those services. (NAC 294A.043)**

**Examples of in kind contributions:** (1) A person contributes billboard space and does not charge the candidate. The candidate would report the fair market value or actual cost of the billboard space as an in kind contribution; (2) A person pays for the printing cost of political signs for a candidate. The candidate would report the actual cost or fair market value of printing the signs as an in kind contribution.

**Example of in kind expenses:** (1) A person contributes the use of a large room to a candidate as an in kind contribution. Once the candidate utilizes the room it becomes an in kind expense to be reported.

## Reporting Requirements

### **WHO MUST FILE (NRS 294A.140; 294A.150; 294A.210; 294A.220)**

#### **Ballot Advocacy Group (BAG):**

Every person or group of persons organized formally or informally who advocates the passage or defeat of a question or group of questions on the ballot an any election including any recall or special election.

#### **Political Party & Committee Sponsored by Political Party (POL):**

Every committee for political action, political party and committee sponsored by a political party which makes an expenditure on behalf of a candidate or group of candidates.

#### **Political Action Committee (PAC):**

Every committee for political action, political party and committee sponsored by a political party which makes an expenditure on behalf of a candidate or group of candidates.

#### **Independent Expenditures (IND EXP):**

Every person who is not under the direction or control of a candidate or group of candidates or of any person involved in the campaign of that candidate or group who makes an expenditure on behalf of the candidate or group which is not solicited or approved by the candidate or group.

### **FILING DATES (NRS 294A.140; 294A.150; 294A.210; 294A.220)**

#### **Report No. 1: August 27,2002 (By 5 p.m.)**

If sent by certified mail, the date mailed is the date filed. The report may be sent in by regular mail, however, the **date received** will then be the **date deemed filed, not** the date mailed.

#### **Report No. 2: October 29,2002 (By 5 p.m.)**

If sent by certified mail, the date mailed is the date filed. The report may be sent in by regular mail, however, the **date received** will then be the **date deemed filed, not** the date mailed.

#### **Report No. 3: January 15, 2003 (By 5 p.m.)**

If sent by certified mail, the date mailed is the date filed. The report may be sent in by regular mail, however, the **date received** will then be the **date deemed filed, not** the date mailed.

### **WHERE TO FILE (NRS 294A.120; 294A.200)**

- If the candidate is elected from one county, or the question is submitted to the voters of only one county, the reports must be filed with the County Clerk/Registrar.
- If the candidate is elected from one city, or the question is submitted to the voters of one city, the reports must be filed with the city clerk of that city.
- All other reports must be filed with the Secretary of State.

### **CAMPAIGN CONTRIBUTION and IN KIND CONTRIBUTION DEFINED (NRS 294A.007)**

**"Contribution"** means a gift, loan, conveyance, deposit, payment, transfer or distribution of money or of anything of value (including in kind contributions). The services of a volunteer are not considered a contribution. Volunteer means a person who does not receive compensation of any kind, directly or indirectly, for the services he provides to a campaign. However, it is a contribution to be reported, if a person, other than a candidate, pays the compensation for the personal services that another person renders.

**In kind contribution** means the value of services provided in kind for which money would have otherwise been paid. The donor of in kind contributions shall furnish to the recipient a statement setting forth the actual cost of those services or, the fair market value.

**In kind contributions and expenses must be reported separately pursuant to NRS 294A.362. For your convenience a form is attached on which to report in kind contributions and expenses.**

### **ANONYMOUS CONTRIBUTIONS (NRS 294A.190)**

A candidate who receives a contribution of \$100 or more from an anonymous or unidentifiable contributor shall, within 10 days after receipt of the contribution, deliver the money to the state treasurer or donate it to a nonprofit entity.

### **CAMPAIGN EXPENSES DEFINED (NRS 294A.004)**

"Campaign expenses" and "expenditures" mean those expenditures contracted for or made for advertising on television, radio, billboards, posters and in newspapers and all other expenditures contracted for or made to advocate expressly the election or defeat of a clearly identified candidate or group of candidates.

### **REPORTS OF EXPENSES (NRS 294A.365)**

Each report of expenses or expenditures required pursuant to NRS 294A.200 must consist of a list of the expenditures made during the periods for reporting.

### **PENALTY SCHEDULE (NRS 294A.420):**

- If the report is filed 1-7 days late, \$25 for each day the report is late.
- If the report is filed 8-15 days late, \$50 for each day the report is late.
- If the report is filed more than 15 days late, \$100 for each day the report is late, up to a maximum of \$5,000.
