- Our Tribal Lands are held in trust by the Federal Government and therefore do not have a monetary value established.
- Homes constructed with HUD funding and are located on trust lands therefore no monetary values have been established.
- All income from agricultural operations on the Reservation is not declarable income.

Our Conservation District Chairman, James Blossom was unavailable for signature however he advised me to complete the form and file on his behalf. Furthermore, our District Supervisors are also requesting waiver of penalties for filing late as none of them received the forms until after the filing due date.
