

Contained in the annual report submitted approximately January 13, 2006, is a declaration of unspent contributions in the amount of \$9,855.05. This sum is inconsistent with that contained in the campaign check register which would suggest an approximate balance on deposit of \$4,940.80. I have been aware of this discrepancy for some time and have inquired of the Financial Services Consultant with Bank of the West, Mr. Manny Saenz. To the best of his knowledge, the overage in the account can be attributed to the failure on the part of a recipient of a check or checks to cash same. To my certain knowledge there have been no additional campaign contributions received since the campaign year 2002.
