


Dear Sir/Madam:

Please find attached a revised submission of my Nevada Financial Disclosure Statement (FDS) which was originally filed with your office on January 14, 2009. The revision is contained in "Section C" of the FDS which lists real property. While I believe this revised disclosure is not required per the FDS instructions and applicable NRS, I do so to be fully transparent and to avoid potential confusion.

The revised FDS clarifies that I own property at 160 Terrace View Street in Stateline, NV 89449 (purchased in 2008). This property is an undeveloped parcel adjacent to my personal residence and serves as an extension (backyard) to my personal residence. The properties are joined by a shared perimeter wall, which includes lighting controlled from within my home. While disclosure of a personal residence is specifically excluded from the FDS, I disclose 160 Terrace View Street because this property utilized as part of my personal residence has a separate parcel number and legal address.
