Attached is the front page of the forms of the website, signed by me, along with a listing of all the contributions the Nevada Faculty Alliance PAC has made in the last reporting period and over the entire year. The total is \$5,200, \$4,500 of which was in contributions of more than \$100.

The NFA PAC raises about \$14,000 every two year cycle through small monthly donations of from \$2 to \$5 from those members of NFA who wish to contribute. Thus we have about \$9,000 left for use in the upcoming 2010 campaigns.

I hope this satisfies both the letter and the spirit of the campaign contribution statutes. As I have noted before, the forms furnished do not really fit well for a small PAC such as our own, but we want to conform to the law as best we can.
