

\* I file under protest as these campaign finance laws violate my constitutional rights to the U.S. Constitution's First Amendment including Freedom of Religion, Speech, Petition and Assembly. They also violate my rights under the Nevada Ordinance "Second", which is part of the Nevada Constitution, which requires a "perfect toleration of religious sentiment," and the Nevada Constitution Sec. 1 Inalienable Rights, Sec. 4 Liberty of Conscience, Sec. 9 Liberty of Speech, Sec. 18. Unreasonable Seizure and Search, and Sec. 20 Rights Retained by the People. The secular affirmation "under penalty of perjury" violates Nevada's required "perfect toleration of religious sentiment" by prohibiting me from filing a religious oath as my beliefs require.
