The People of the State of Nevada do enact as follows:

Explanation: Language in **boldface italics** is to be added to The Nevada Constitution; language between brackets [~~deleted language~~] is to be deleted.

Article 2 Section 5 of The Constitution of Nevada is amended to read:

Voting by *secret* ballot; voting in elections by legislature.

1. ~~[All elections by the people shall be by ballot, and]~~ *The right of individuals to vote by secret ballot is fundamental. Where local, state, or federal law permits or requires elections for public office and ballot measures, the right of individuals to vote by secret ballot shall be guaranteed.*

2. ~~[a]~~ All elections by the Legislature, or by either branch thereof shall be "Viva-Voce".
